1. The firms/contractors/JVs should have relevant experience not less than Seven (7) years for categories A, B, C, D, not less than five (5) years for E, G, J, K, M, N, Q, R, S and not less than three (3) years for categories F, H, I, L, O & P.
2. Name and address (registered office) and branch offices. Status of firms (i.e. partnership, JV or limited).
3. Registration of firm with Pakistan Engineering Council, renewed for the year 2022-2023.
4. Copies of latest NTN and GST/ Provincial Sales Tax (Punjab, Sindh, KPK - where applicable) registration certificates.
5. An undertaking affidavit by the firms to the effect that "neither the firm nor its directors/stakeholders, as whole or as a part of the firm have ever been blacklisted/defaulted by any government agency/department/civil organization/financial institutions and also that information supplied by the consultant/firm/JV/contractor is correct.
6. Bank/Account financial statements for last three years.
7. Average Bank Balance Maintenance Certificate/letter from Bank.
